Wasting Money

Lambeth say that the purpose of what they are doing at Carnegie and other libraries is to save £801,000 a year by 2020. However there is no sign of any savings emerging.

The table on the right has been prepared by the People's Audit and lists $£7^1/_2$ million of additional expenditure they have traced in respect of libraries. No doubt there will be expenditure they have not traced and, of course, we have another two years of spending between now and 2020.

Lambeth insist that there is no business plan for the gym they are installing in the basement but that they are sure it will generate income for the building from 2022 onwards. However there are plenty of gyms which are in locations more convenient for most potential users, offer a wider range of activities and are cheaper than GLL/Lambeth's £19.95 minimum monthly fee.
